




VISUAL TIME LINE: Portions 7, 43 & 104 of GANSE VALLEI 444 (Knysna RD)

I WAS BORN ON THE FARM RIETVELD (NOW KNOWN AS 644 GANZEVALLEI) IN 1936. MY PARENTS USED THE ENTIRE FARM FOR CROPS & WHERE IT WAS TOO STEEP, THESE AREAS WOULD BE USED FOR LIVESTOCK PASTURE. THE FARM WAS LATER SUBDIVIDED AND PORTIONS GIVEN TO FAMILY MEMBERS WHO CONTINUED FARMING WITH LIVESTOCK & THE CROPS WERE CORN, PUMPKIN (BOTH WHITE & BLUE) POTATOES, OATS. 
