AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 27 JUNE 2019 FOR THE DEVELOPMENT OF THE ALLEPAD TWO, 100MW PHOTOVOLTAIC SOLAR ENERGY GENERATION FACILITY AND ITS ASSOCIATED INFRASTRUCTURE NEAR UPINGTON WITHIN THE DAWID KRUIPER LOCAL MUNICIPALITY IN THE NORTHERN CAPE PROVINCE

The Environmental Authorisation (EA) issued for the abovementioned application by this Department on 27 June 2019, the amendment dated 15 July 2019, your application for amendment received by the Department on 20 June 2024 and the acknowledgement letter dated 01 July 2024, refer.

Based on a review of the reason for requesting an amendment to the above EA, this Department, in terms of Chapter 5 of the NEMA EIA Regulations, 2014 as amended, has decided to amend the EA dated 27 June 2019, as amended as follows:

Reason for the Amendment:

The Applicant applied to update the contact details of the Holder of the EA to the current Director of the holding company.

Amendment 2: Amendment to extend the validity period of the EA:

From:

"This activity must commence within a period of five (5) years from the date of issue of this environmental authorisation. If commencement of the activity does not occur within that period, the authorisation lapses and a new application for environmental authorisation must be made in order for the activity to be undertaken.

To:

"The activity must commence within a period of ten (10) years from the expire date of issue of the Environmental Authorisation issued on 27 June 2019. The EA will now lapse on **27 June 2029.** If commencement of the activity does not occur within that period, the authorisation lapses and a new application for environmental authorisation must be made in order for the activity to be undertaken."

Reason for the Amendment:

The Applicant applied to extend the validity period of the EA, as they intend to bid this project in the REIPPPP future rounds, requiring a valid EA.

This proposed amendment letter must be read in conjunction with the EA dated 27 June 2019, as amended.

In terms of the Promotion of Administrative Justice Act, 2000 (Act No. 3 of 2000), you are entitled to the right to fair, lawful and reasonable administrative action, and to written reasons for administrative action that affects you negatively. Further your attention is drawn to the provisions of the Protection of Personal Information Act, 2013 (Act No. 4 of 2013) which stipulates that the Department should conduct itself in a responsible manner when collecting, processing, storing and sharing an individual or another entity's personal information by holding the Department accountable should the Department abuses or compromises your personal information in any way.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, as amended (the EIA Regulations), you are instructed to notify all registered interested and affected parties, in writing and within fourteen (14) days of the date of the decision, of the Department's decision as well as the provisions regarding the submission of appeals that are contained in the Regulations.
