LANDING STRIP ON PORTION 1 OF FARM 172,  
HONIG KLIPS KLOOF, HERBERTSDALE

### Notice is hereby given of a Public Participation Process in terms of the National Environmental Management Act (NEMA, Act No 107 of 1998 as amended)

An application for a **Basic Assessment** has been submitted to the Department of Environmental Affairs and Development Planning (DEA&DP) as the competent authority for decision making.

**Proposal:** Establishment of a private vegetated landing strip ( $\pm$  2.3ha) for private flights (owner and/or guests) and for fire-fighting and anti-poaching operations. An area around the landing strip will be brushcut for better visibility. The proposal also entails a hangar with a compacted grass apron/parking, a turning circle area, a taxiway and a small water reservoir, next to the runway, on  $\pm$  0.68ha.

**Location:** Portion 1 of Farm 172 Honig Klips Kloof is located approximately 15km east of the town Herbertsdale. The property is directly north of the Gondwana Private Game Reserve and can be accessed from an unnamed gravel farm road, traversing the reserve, directly off the R327 towards Herbertsdale.
