


MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY


MAP OF RELATIVE AQUATIC BIODIVERSITY THEME SENSITIVITY


MAP OF RELATIVE DEFENCE THEME SENSITIVITY


MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY
